# Athens energy storage project approval requirements





#### **Overview**

Is Greece preparing a new 3.5 GW energy storage program?

A decision published by Greece's Ministry of the Environment and Energy in the State Gazette last Friday was a surprise for the domestic energy storage sector. The ministry ran a public consultation in late February, proposing a new 3.5 GW energy storage program.

What is Greece's new battery storage program?

Greece's new battery storage program has taken into account the areas most congested by the output of renewable power stations as well as the kind of renewable projects connected to the grid.

Will Greece provide financial support for 900MW energy storage capacity?

The government in Greece is looking to provide financial support for up to 900MW of energy storage capacity through a tender as previously reported by Energy-Storage.news. The country has an overall energy storage deployment goal of 3GW by 2030 to facilitate a 70% renewable energy target.

Who can use electricity storage?

More specifically, the activity of electricity storage is permitted to natural or legal persons who have been granted an electricity storage license or who have been legally exempted from this obligation, such as injection power storage stations of less than one megawatt (1 MW) (Article 132E § 2 of Law 4001/2011).

Which energy storage projects have been approved by the Energy Regulatory Authority?

What is the future of battery storage in Greece?

Overall, following last months public consultation, the Greek ministry of the environment and energy presented a bolder and even more ambitious battery storage program, allowing for longer completion times but retaining the financial and competition guarantees in place.




