Overview

Import/export According to the "Commodity Inspection Law," lithium battery packaging manufacturers must apply to their local customs for performance testing of dangerous goods packaging before export and obtain the "Dangerous Goods Packaging Certificate." Can you export batteries?

You can't export batteries unless the receiving country has the infrastructure and capabilities to handle them safely. Prior Informed Consent: Before exporting batteries, exporters must secure consent from importing countries. This guarantees that the receiving country understands the risks and has the capability to manage the waste safely.

Do you need an abto to export a battery?

The rules are different for waste portable, industrial and automotive batteries. You must be an Approved Battery Treatment Operator (ABTO) if you: You must be an Approved Battery Exporter (ABE) if you: Evidence notes are proof of treatment, recycling or export of portable waste batteries by an ABTO or ABE.

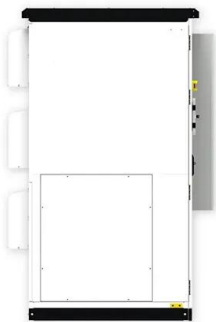

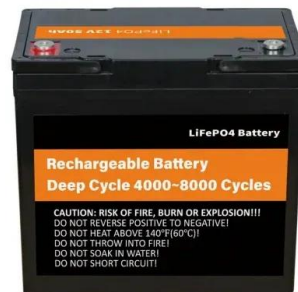
