Warranties for Battery Energy Storage Systems (BESS) provide mechanisms for buyers and investors to mitigate the technical and operational risks of battery projects, by transferring the risk of defects or performance issues to the manufacturer or the battery vendor.

Warranty lifecycle and the warranted calendar life of the battery to include: (i) a clear and simple proration formula, for crediting the buyer for unused capacity of equipment replaced or repaired; and (ii) end of life definitions, including calendar age and number of complete charge-discharge cycles (throughput).

What is a battery energy storage system (BESS)?

Battery energy storage systems (BESS) respond rapidly to control signals, are easy to deploy, and are benefiting from cost reduction trends. By contrast, most mainstream technologies cannot provide long duration storage, often fail to withstand harsh climatic conditions, or require frequent operation and maintenance.

Are new battery technologies a good choice for developing countries?

New battery technologies have valuable attributes that are well suited to the needs of developing countries. However, their limited track record can hamper its widespread deployment.

How does a warranty work?

Warranties for other assets work in the same way: for example, those for solar PV plants guarantee material and workmanship for up to 10 years. The module manufacturers guarantee a certain output for the first year, and then reduce it linearly each year for up to 25 years by a proportion of the nominal output power.

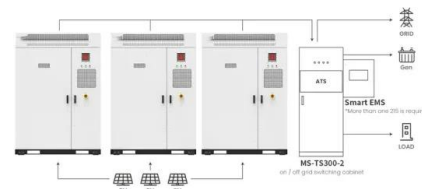
