

# How much is the tariff for energy storage batteries in North Macedonia





#### **Overview**

Does North Macedonia have a free trade agreement?

Preferential tariffs apply to countries with which North Macedonia has signed a bilateral Free Trade Agreement, as well as to countries participating in multilateral trade agreements, such as the EU Stabilization and Association Agreement (SAA), European Free Trade Agreement (EFTA), and Central European Free Trade Agreement (CEFTA).

What is the new VAT rate in North Macedonia?

A new tax reform passed by Parliament September 19, 2023, moved a few hundred non-essential products to a new VAT preferential rate of 10 percent. For imports into North Macedonia, VAT is assessed on the customs value of the goods plus the customs duty and excises.

Is North Macedonia a EU candidate?

As an EU candidate, North Macedonia continues to harmonize its customs' laws with EU laws and regulations. Customs duties generally apply to most products imported into North Macedonia.

Is North Macedonia a WTO member?

North Macedonia joined the World Trade Organization (WTO) in 2003. As a WTO member, North Macedonia has committed itself to the three basic rules of trade conduct: legislative and regulatory transparency, equal rights and privileges for foreign and domestic firms and citizens, and most-favored nation treatment.


