# Mandatory inspection items for battery cabinets





#### **Overview**

What are the safety requirements related to batteries & Battery rooms?

Employers must consider exposure to these hazards when developing safe work practices and selecting personal protective equipment (PPE). That is where Article 320, Safety Requirements Related to Batteries and Battery Rooms comes in.

Do you need documentation before entering a battery room?

It is a requirement to have all the documentation in place prior to authorized personnel entering a battery room to perform a specific work task on a battery system under normal operating conditions. However, it is likely the employee will need to enter the battery room to deal with a battery system that is not operating normally.

What are the requirements for a reg system inspection?

Completeness of the documentation and its correspondence with the REG system on-site, as per SEC's inspection checklist. Inspect the presence of Interface Protection and required switches. Witness Compliance test to be performed if necessary, during cold commissioning. Temporary connection granted (known as "Limited Operational Notification").

Are battery storage systems dangerous?

There has been a fair amount of news about battery storage systems being involved in fire and explosion incidents around the world. Do not forget that these are not the only safety issues when dealing with batteries. Battery systems pose unique electrical safety hazards.

What happens if you send an employee into a battery room?

Sending an employee who is trained only for the normal operating conditions into a battery room under thermal runaway, for example, is knowingly exposing an unqualified person to risk of injury. The employer is responsible



for protecting their employees from known or recognized hazards in the workplace.

What are the risks of working with batteries?

Working around batteries can expose an employee to both electrical shock and arc flash hazards. A person's body might react to contact with dc voltage differently than from contact with ac voltage. Batteries can also expose employees to the hazards associated with the chemical electrolyte used in batteries.
