# Requirements for exporting photovoltaic modules to Nigeria







#### **Overview**

Required Documents for SON Registration include: duly completed application form, valid product certificate, company certificate of incorporation, photographs of the product, manufacturer's agreement, trademark certificate (if applicable), list of items to be imported and sample proforma invoice. Should Nigeria impose a 10% import duty on solar panels?

While the Nigerian Customs Service's 10% import duty on solar panels may have economic justifications to generate revenue for the federal government amidst the renewable energy boom in Nigeria, it is important to consider the socio-economic implications of making affordable and accessible power available to everyone through renewable energy.

What is the import process in Nigeria?

The import process in Nigeria involves a number of steps. Before any importation is carried out, the following must be done by the importer: Register the company name in Nigeria and hence have a Certificate of Incorporation/Registration of the company in Nigeria.

How do I import a form m / pre arrival Assessment Report (Paar) in Nigeria?

Select a Bank of choice in Nigeria to act as the Authorised Dealer Bank (ADB). This is the Bank that will process the Form M / Pre Arrival Assessment Report (PAAR), as well as mediate among the Nigeria Customs Service (NCS), the importer and other bodies. Once the above is done, the importer is ready to import into Nigeria.

How to register a company in Nigeria?

Register the company name in Nigeria and hence have a Certificate of Incorporation/Registration of the company in Nigeria. Register the company with the Federal Inland Revenue Services (FIRS) with an up-to-date proof of Tax Payments, upon which a Tax Identification Number (TIN Number) is allotted, with a valid e-mail address tagged to it.
