

# UK container energy storage regulations





#### **Overview**

Is energy storage regulated?

Whilst the Department of Business, Energy & Industrial Strategy ("BEIS") and Ofgem have been supportive of energy storage and recognise the benefits and flexibility provided by the various technologies, there is no specific legislation on or regulation of storage at present.

What are the safety requirements for electrical energy storage systems?

What are the standards for battery energy storage systems (Bess)?

Introduction As the industry for battery energy storage systems (BESS) has grown, a broad range of H&S related standards have been developed. There are national and international standards, those adopted by the British Standards Institution (BSI) or published by International Electrotechnical Commission (IEC), CENELEC, ISO, etc.

Can energy storage be co-located?

Co-location with generation (particularly renewables) is also high on the energy storage agenda. Earlier this year, Western Power Distribution, a DNO, signed a contract with RES (a renewable energy company) to deliver an energy storage system co-located with a 1.5MW solar farm.

Who regulates electricity storage?

Ofgem is the relevant regulator for electricity storage, though as noted above there is no specific storage regulatory regime. Ofgem has recognised that there are regulatory changes required to enable the full commercial development of storage and it has committed to working with other



stakeholders to consult on such changes.

How does the Energy Act 2008 affect CO2 storage?

Key Regulations The Energy Act 2008, adopted in line with EU Directive 2009/31/EC on the geological storage of carbon dioxide, establishes a regime for the regulation of CO2 storage and introduced a licensing requirement for offshore CCUS.


